### **Concord Naval Air Station ReUse Planning**

'The re-use of the Concord Naval Weapons Station (CNWS) presents Concord and the surrounding region with a momentous opportunity to create a world-class project that represents the vision and values of the community. The planning and design process can address the needs of Concord residents and fulfill priorities for open space, affordable housing, quality jobs, vibrant neighborhoods, and environmentally sustainable development. Given the broad impacts, it is critical for the benefits of the base re-use to be shared by the public throughout the city and region. The Community Coalition for a Sustainable Concord \* (CCSC) forwards the following comprehensive vision to preserve open space and the environment; cluster sustainable, affordable development around the BART station and other transit centers; and promote inclusiveness and a high quality of life for all:

- Open Space and Natural Resource Protections Preserve 80% of the CNWS land as open space and park, including the entire area east of Mount Diablo creek.
- Create a new public regional park for hiking, biking and equestrians and preserve endangered species habitat.
- Protect wildlife corridors, and designate a 300-foot creek buffer for restoration. Prevent any new roads east of Mount Diablo creek. Promote environmental education to complement the protection of sensitive resources. Develop a linear park along the western boundary to buffer existing neighborhoods, bring together older and newer neighborhoods, and benefit all of the region's residents with sites for active recreation, sports fields, museums, and other amenities.
- Have trails and wildlife corridors connect to pocket parks, playgrounds, the regional park, and regional trails and bikeways -- ensuring that all of Concord benefits and that the area doesn't become "New" Concord at the expense of downtown and other existing parts of the city.

## **Monterey Horse Park - An Opportunity to Keep Fort Ord Open for Equestrians**

Monterey Bay Equestrians is again coordinating a docent walk through the planned Monterey Horse Park for local horseman's club representatives. As we all know – many of our parks are in danger of being closed completely, or being closed to equestrian access. If we unite together, we can protect our parks and our access rights. This walk is an opportunity for local horsemen to band together to support MHP and ensure that the Fort Ord lands and trails we all enjoy today remain accessible to equestrians in the future. The Docent Walk is an initial step in banding together leaders from a number of clubs around the bay area and central coast to garner support and raise awareness for this wonderful facility. The date is March 12th, with a rain date of the 26th .

Dr. Tim Eastman of Steinbeck Equine and a board member of MHP will be leading us through the area designated for the horse park, describing the facilities it will offer for all equestrians. The Monterey Horse Park offers a unique opportunity for horsemen of every discipline and skill level to enjoy our beautiful area while learning and expanding their equestrian abilities. The current vision is for MHP to construct and operate a multi-discipline equestrian park, located on approximately 390 acres of land (including habitat reserve) in Parker Flats, on the decommissioned military base, Ft. Ord, in Monterey County, California.

The facility will promote the training of amateur equestrians and host breed shows and competition in all eight Federation Equestre Internationale (“FEI”) disciplines including dressage, eventing, jumping, vaulting and reining as well as cutting and working cow horse events. For the more leisurely inclined, the park offers trail access and camping facilities to support Endurance and NATRC events as well as warm weekend respites with our equine friends.

We MUST help make this facility a success to protect our equestrian trails and parks. As a beginning, we'd like to invite two members of your club to join us on this day to tour the planned facility area and to discuss plans and opportunities for how we can support MHP. An agenda and overview is attached.

## **New River Trail May Link American Canyon, Napa**

"The Napa River is walking distance from American Canyon's newest subdivisions, but residents of the area and other members of the public have no access to the river as it heads south on the stretch run toward Mare Island and the bay. That may soon change.

While American Canyon and Napa County officials have been at odds over several issues, the city and the ***new Napa County Parks and Open Space District*** have collaborated on plans for an 8.5-mile river trail between American Canyon and Napa. The trail is among a ***dozen projects the Napa County Parks and Open Space District has undertaken during its first year in business***. The district, which operates on a \$350,000 budget, was formed after voters approved Measure I in November 2006 with the goal of opening more than 100,000 acres of public land to hikers and other users. American Canyon contributed about \$9,400 to expand the study of the 8.5-mile long path, which will travel along former salt ponds that the California Department of Fish and Game wants to restore into wetlands. The trail will form a segment of the San Francisco Bay Trail, a network of trails that ring the region from San Francisco's Ocean Beach to the oak-studded East Bay hills. The first section of the trail between Napa and American Canyon may be constructed this summer, if the parks district receives a \$1.3 million state grant, said John Woodbury, the district's general manager. The city will use an \$800,000 transportation grant to contribute to the project. "John Woodbury is doing a great job," said Randy Davis, community services director for the city of American Canyon. "We've got a lot of work (done) with very little money." Construction of the entire 8.5 mile-long trail, estimated to cost \$11 million, could take place in 2010, though that may depend on negotiations between the district and a half-dozen agencies that own property the trail is expected to cross.

As the Open Space District hits its first annual milestone, it has other projects in the works.

***Five miles from Napa, the district wants to reopen rugged areas around Milliken Reservoir to the public. An old network of trails near the reservoir was used by students and others until state cutbacks hit after Proposition 13, according to the district. The old network would have to be rebuilt and new trails created, Woodbury said. He's also exploring the possibility of having RV travelers willing to donate 15 to 20 hours a week to serve as caretakers in exchange for being able to use the area.***

Upvalley, near Calistoga, the district plans to do erosion repairs and put direction signs at Oat Hill Mine Trail, a historic road popular with hikers and bikers.

Near Lake Berryessa, Napa County recently used about \$120,000 in Prop. 12 funds to buy a 224-acre former scouting camp from the Land Trust of Napa County. The district hopes to have an educational camp in operation in 18 months.

Other future Napa County Parks and Open Space District grant-funded projects include:

- Opening public trails at Lake Hennessey
- ***Creating a new loop trail on 320 acres now owned by the Bureau of Land Management near Lake Berryessa***
- Restoring a meadow on land Fish and Game owns along the Napa River
- Opening public access to wetlands south of Napa

***The district also hopes to complete the ever-elusive acquisition of Skyline Wilderness Park\* in Napa. Gov. Arnold Schwarzenegger last year vetoed a bill that would have given the county preference in acquiring the 850-acre east Napa property from the state and preserving it as a park.***
