SAVING LANDS AND TRAILS FOR HORSES IN THE SAN FRANCISCO BAY AREA

Bay Area Barns and Trails is a land and trails trust whose mission is to preserve publicly accessible trails, barns, stables, pastures, staging areas, and horse camps in Alameda, Contra Costa, Marin, Napa, San Mateo, San Francisco, Santa Clara, Solano, and Sonoma Counties.

Bay Area Barns and Trails (BABTT) was incorporated in 1999 as a California non-profit 501 (c) (3) corporation; Federal Tax Exemption was granted in November, 2000. We work with public and private landowners, trail associations, environmental and open space advocates, and community groups. We have encouraged, educated, advised, referred, and provided educational and financial help to equestrians in American Canyon, Bodega, Brentwood, Castro Valley, Fairfax, Half Moon Bay, Hayward, Lafayette, Livermore, Los Altos Hills, Lucas Valley, Martinez, Mendocino, Mill Valley, Napa, Orinda, Rossmoor, San Geronimo Valley, San Rafael, Santa Cruz, Santa Rosa, Saratoga, Sonoma, Walnut Creek...and Massachusetts! Since November 2000 thirteen equestrian organizations or public agencies have been awarded \$37,000 in acquisition, stewardship, education and capacity building grants.

Bay Area Barns and Trails adopted a resolution of support for the Land Trust Alliance 'Standards and Practices' during the May 2002 Annual Meeting. Land Trust Alliance 'Standards and Practices' are guidelines to operating a sound, effective, and sustainable land conservation program including the implementation of sound programs of land stewardship, public/private landowner support, education, and transactions; and demonstrates that the organization operates legally, ethically,

and in the public interest.

LTA Standards and Practices Adopted

What Can a Land Trust Do to Save Equestrian Lands and Open Space?

"...Land trusts protect open space of all kinds--wetlands, wildlife habitat, ranches, shorelines, forests, scenic views, farms, watersheds, historic estates, and recreational areas--land of every size and type that has conservation, historic, scenic, or other value as open space. Land Trusts



are nonprofit, voluntary organizations that work hand-in hand with landowners ... using a variety of tools, such as conservation easements that permanently restrict the uses of the land, land donations, purchases and strategic estate planning. Land Trusts help protect America's open spaces and green places, increasingly threatened by sprawl and development." Local and regional land trusts have protected approximately 4.7 million acres of wetlands, wildlife habitat, ranches and farms, shorelines, forests, recreation land and other property of ecological significance. Indeed, the number of local land trusts has grown phenomenally, from 743 in 1985 to more than 1,200 today..." - Land Trust Alliance www.lta.org

In mid-September, Judy Etheridge, Maggie Kelly, and Barbara Weitz met with the landowner to discuss plans for the facility which has the potential to house a dozen or more horses. The stables also offer trail access onto existing Alum Rock Park trails and future trail connections to Joseph Grant Park. BABTT representatives will meet with City, County and Park staff to determine feasibility of the purchase and geotechnical issues. San Jose Preserves Open Space for Mounted Unit at Tully Road and Kenoga Drive Community opposition to a plan to take green pastures away from the hard working San Jose Police Department's Mounted Unit seems to have been effective...at least for now. The latest park plan - according to David Mitchell of the City's Department of Parks, Recreation and Neighborhood

Services - will provide the mounted unit with a 'replacement' pasture near Stonegate School. Maggie Kelly, 5th generation Santa Clara resident has alerted many Santa Clara County residents, including Congresswoman Zoe Lofgren and Secretary of Transportation Norm Mineta, to the realization that the Mounted Unit must remain where they are - accessible to downtown and with plenty of greenspace to rest and play. The City will move one element of a proposed building project away from the 'Mounted Unit' stables...but the ballfield remains on the drawing board - a ballfield which will obliterate verdant greenspace near Coyote Creek -'birdsongs will be replaced by 'battersup!' Los Altos Hills' Residents Plan Voters' Initiative Which will Require Public Approval for Sale of Public Lands A Council member's proposal to inventory town-owned property for possible 're-use' spurred horse lovers and open-space advocates into action as speculation arose about the possible sale of the Westwind Community Barn, the crown jewel in the city's collection of open spaces. After Mayor Toni Casey and other council members ordered an inventory of town-owned property as well as an assessment of how each of the 27 parcels might be put to best use, fears arose that the properties would be lost to the highest bidder. In 1975 an Hungarian countess, Margit Bessenyey, donated Westwind and the land around to the town without restriction. `When land is given to a community by someone who's dying, it would be appalling for a few people on the city council to turn around and sell it," said John Metcalfe, one of the organizers of the initiative drive. Nancy Couperus, a founder of Friends of Westwind Barn, noted that the loss of Westwind would be felt beyond the exclusively residential town of Los Altos Hills. 'It would be a shame', she said, 'to see Westwind wind up in private hands.' These concerns led the Los Altos Hills Open Space Committee to plan an initiative to ensure that the public will have final say in this issue. Council

candidates Dean Warshawsky and Breene Kerr are both actively supporting its passage through their individual campaigns. Neighborhood gatherings are explaining the initiative to residents. Organizations including the Audubon Society of Santa Clara Valley, Bay Area Barns & Trails, and the Committee for Green Foothills have contributed funds to help the Committee raise \$20,000 for legal costs. Contributions are still needed. Contributions of more than \$250.00 to support this initiative will be taxdeductible because the Audubon Society will accept donations payable to LAHills Open Space. So instead of making your check out to LAH Open Space, for these larger donations just make your check out to 'Santa Clara Valley Audubon Society with the notation 'LAHills Open Space.' SOLANO COUNTY

Trail Dedication Hike and Ride in Lynch Canyon - Saturday, November 2, 2002

Explore a new link in the Bay Area Ridge Trail through Lynch Canyon just northwest of Interstate 80 between American Canyon Road and Highway 12, also known as Jameson Canyon Road.

Lynch Canyon was acquired by the Solano Land Trust in 1996. It provides a perpetual agricultural and open space buffer along Interstate 80 between the cities of Fairfield, Vallejo, and Benicia. Funding for the \$4.2 million purchase was garnered from many sources: Tri-City and County Cooperative Planning Group, City of Fairfield, State Legislature, State Parks, California Transportation Commission, California Department of Fish and Game (CDFG), Federal Intermodal Surface Transportation Efficiency Act (ISTEA) program (as mitigation for freeway development), and other sources. And, the Trust continues to make payments on a 20-year mortgage. Docent guided access will be provided for hikers. mountain bicycle riders, and horseback riders. Johnson Ranch to be acquired by
Sonoma County Agriculture and Open
Space District; Future of the remaining
70-acre parcel is uncertain.
The Johnson Ranch, east of Hwy 12/
south of Santa Rosa, has the potential
to connect Annadel State Park, Spring
Lake Regional Park, (after crossing
Hwy 12) Hood Mountain Regional
Park and Sugarloaf State Park.

The District has made an offer to acquire 300 acres of the 370-acre Johnson property. A buyer is being sought for the remaining 70-acres.


Equestrian Land and Trail Stewardship Grants Available for Spring/Summer 2003 -\$500.00 - \$2,500.00

BABTT 2002 Grants to Equestrian Organizations

CONTRA COSTA COUNTY

Muir Heritage Land Trust/Martinez Horsemen's Association Benefit Ride Earns \$7.790 Bay Area Barns and Trails again matched funds raised during 3rd Annual Martinez Horsemen's Association Benefit Ride, Sept 14, 2002. Over the past three years, Martinez Horsemen's Association (MHA) has raised over \$16,000 during its fundraising rides to benefit preservation, acquisition, and stewardship work of the Muir Heritage Land Trust. The rides have increased public awareness of the Land Trust's mission within the equestrian community. This year's ride followed a reclaimed segment of Contra Costa Feeder Trail #1 and also explored parts of Franklin Canyon. Although Feeder Trail #1 is still officially closed pending a formal survey and work on the grading and drainage, tremendous progress has been made in clearing the route. MHLT has been working with private landowners along the trail, as well as East Bay Regional Parks District, Contra Costa County, the Bay Area Ridge Trail Council (BARTC) and the California Conservation Corps. BARTC will contribute \$117,900 from its share of the Park Bond monies for planning and negotiating improvements to this historic 'Feeder' trail.'

MARIN COUNTY

Ocean Riders of Muir Beach received \$2,500 to improve water quality in the Redwood Creek Watershed. Volunteers will install a frame for their manure bin tarp cover, install rubber dams along driveway, and install roofing to protect the lower portions of the paddocks from excess runoff. Public/private partnerships with the Marin/Sonoma Resource Conservation District and other public agencies working to enhance the Redwood Creek Watershed, including the National Park Service, Muir Woods National Monument, Golden Gate National Recreation Area; and California State Parks/Marin District/Mt. Tamalpais State Park, will keep salmon thriving in Redwood Creek.

Alto Bowl Horseowners Association received \$150.00 to help defray volunteer expenses during its annual 'green' work party on Horse Hill Open Space. Volunteers removed invasive plant species - including scotch and french broom, preserved the land for future generations of visitors and wildlife; and strengthened the public/private partnership with the Marin County Open Space District.

SONOMA COUNTY

Back Country Horsemen/North Bay Unit awarded \$1,917.00 to install a manure bunker and hitchrails in Oak Knolls Equestrian Parking Lot - Spring Lake Regional Park/Santa Rosa. The manure bunker protects a nearby drainage ditch and stream from manure runoff AND provides composted product for the local gardeners. The hitching rails provide a secure place to tie horses and will eliminate scarring of trees from rope burns. The work was accomplished by public/private partnership of BCHA/North Bay volunteers and Annadel State Park and Spring Lake Regional Park staff. Donors and volunteers included the Russian River Riders, Sonoma County Riding and Driving Club, Petaluma Riding and Driving Club, Sonoma County Horse Council, Wine Country Peruvians, Reliable Hardware, Pace Supply, Slakey Bros., Inc., Cameron and Cameron Ranch Supply. www.bchc.org

SANTA CLARA COUNTY

\$500.00 in 'startup funds' helped volunteers work towards permanent preservation of Los Altos Hills Open Spaces, including the Byrne Preserve and Westwind Barn. These beautiful open lands and unique horse property must be protected from sale or development, for it was the expressed intent of the generous persons who donated the land to the city of Los Altos Hills that the land be preserved forever. 'At stake: 15 acres of horse heaven -- rolling pastures; riding ring; a 17-stall, U-shaped stable; and all the brushing and pampering a horse could want. Located at the top of Altamont Road, the barn is home to several horse programs for teens, disabled children and others from around the Bay Area.'

To paraphrase a recent article appearing in the San Jose Mercury News (6/19/02) written by Huey D. Johnson, founder of Defense of Place: 'The question is one of permanence. What is our obligation to continue to preserve parks created by past generations? When we promise to preserve such spaces in perpetuity, how long is forever?' - Westwind Barn www.westwindbarn.com

NAPA COUNTY

Skyline Wilderness Park Citizen's Association received \$500.00 to purchase poplar trees for the horse camp in Napa's Skyline Wilderness Park. The trees will help with erosion control and provide shade for horses and campers...a multi-benefit project demonstrating environmentally responsible techniques for enhancing lands enjoyed by equestrians and their friends.



Accomplished through a public/private partnership of Skyline Wilderness Park Citizen's Association under the leadership of Mary Widmeyer, the Napa Valley Saddlejackets, and the Napa Chapter of the Native Plant Society.

BARGAIN SALE

A useful tool for a landowner interested in conservation who cannot donate land directly. A bargain sale of property to a land trust insures the land will be protected. With this option, the land trust purchases land at less than full-market value. The benefit to the landowner is twofold:

- 1. the sale produces needed income and,
- 2. he/she can claim the difference between the sale and full-market value as a tax-deductible donation.
